REGULAR VILLAGE BOARD MEETING 6:30 PM, JUNE 9, 2009

A. MOMENT OF SILENCE

C. ROLL CALL

Board: Trustees Herr - present, Mau - present, Boyle - present, Reynolds - present, Kavanagh - present, Schatteman - present, and President Gray - present.

D. HEARING OF CITIZENS

Darren Clarke and Adam Neal of Foxx Creek Subdivision asked for the installation of stop signs at Ptarmigan/Piazza and Garvey/Trace Lane, respectively. They said traffic conditions make the area dangerous without stop signs. Village Engineers will study their requests and respond.

Mike Zahn, representing union employees belonging to the Local Operating Engineers union, spoke to the board about current contract negotiations. He said union represented employees have been working for six weeks without a contract.

He accused management of threats and intimidations during contract negotiations and asked for an up or down vote on their proposal. Attorney Myers said contract negotiations are conducted by a village negotiating committee, not the board. Mayor Gray said the board meeting was not the proper place to discuss or vote on contract negotiations. Mr. Zhan said employees are not going to work much longer without a contract.

Kris Cannon of Bens Drive complained to the board about a dangerous American Bulldog dog in her neighborhood that attacked her dog. She showed pictures of her dog's wounds which required surgery. Other attending neighbors also complained about the dog attacking other dogs and people. Sangamon County Animal Control has declared the dog dangerous and the Chatham Police are aware of the problem. The dog owners are Cindy and Russell Johnson. Attorney Myers asked Ms. Cannon to send him her dog's bills and Mayor Gray said the village and the police will work to remedy the dangerous situation.

President Gray asked for a motion to amend the agenda for an Executive Session, to discuss topics of Personnel and Collective Bargaining, after Calendar of Events. Trustee Kavanagh made that motion, seconded by Trustee Reynolds. Chief Barnett retired, affective April 30, 2009.
