#### **ORDINANCE NO. 15-**

# AN ORDINANCE APPROVING AN EMERGENCY WATER SYSTEM INTERCONNECTION AGREEMENT BETWEEN THE CITY OF SPRINGFIELD AND THE VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the City owns and operates a water supply distribution system, and

WHEREAS, the Village currently purchases its water supply from the South Sangamon Water Commission (SSWC), and

WHEREAS, the Village and the City are currently in negotiations for a permanent backup water supply agreement, and

**WHEREAS,** on November 3, 2015, the Village experienced an unexpected drop in tank levels, and

**WHEREAS,** the Village requested that the City provide an emergency water backup supply to the Village on that date, with the understanding that a permanent backup water supply agreement will be finalized in the next three (3) months, and

**WHEREAS,** the City was willing to immediately sell water to the Village under the terms and conditions of this agreement.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** <u>Approval of Emergency Interconnection Agreement</u>. The Board of Trustees of the Village hereby approve the Emergency Water System Interconnection Agreement

between the parties (attached hereto).

Section 3. <u>Authorization</u>. The Mayor is hereby authorized to enter into the

Emergency Interconnection Agreement attached hereto.

**Section 4**. Severability. In the event a court of competent jurisdiction finds this

ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall

not affect the validity of the remaining provisions of this ordinance and the application thereof to

the greatest extent permitted by law.

Section 5. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict

herewith are hereby repealed; provided, however, that nothing herein contained shall affect any

rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to

the effective date of this ordinance.

**Section 6**. Effective Date. This Ordinance shall be in full force and effect from and after

its passage, approval and publication in pamphlet form as provided by law.
