ORDINANCE VACATING A PART OF GLENN DRIVE

WHEREAS, Lloyd Fite platted "Fite's Subdivision Plat I" in the Village of Chatham; and

WHEREAS, Lloyd Fite in said plat dedicated to the Village of Chatham a street to be known as Glenn Drive as shown on the plat; and

WHEREAS, Glenn Drive as dedicated to the Village of Chatham ends in a cul-de-sac; and

WHEREAS, the corporate authorities of the Village of Chatham are advised as to the nature of said cul-de-sac and its usage by the citizens of Chatham; and

WHEREAS, notice of the Village of Chatham's proposed vacation of the cul-de-sac located on Glenn Drive has been given to all the property owners in Fite's Subdivision Plat I; and

WHEREAS, the corporate authorities of the Village of Chatham have determined that it is in the public interest to remove the cul-de-sac from Glenn Drive, and to vacate the same in accordance with Sections 11-91-1 and 11-91-2 of Chapter 24 of the Illinois Revised Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHATHAM, ILLINOIS:

SECTION 1. The cul-de-sac at the end of Glenn Drive in Fite's Subdivision Plat I dedicated to the Village of Chatham is abandoned, and those parts of Glenn Drive forming the cul-de-sac which are also parts of Lots 6 and 7 of Fite's Subdivision Plat I are hereby vacated and title to said parts vests in the present owner of Lot 6 and 7 of Fite's Subdivision Plat I. Glenn Drive to be of the same width in front of said Lots as it is throughout said Subdivision. Lots 6 and 7 of Fite's Subdivision Plat I now to have a depth of 118.46 feet and a width of 81.89 feet and to be rectangular in shape.

SECTION 2. The Mayor is authorized to sign and the City Clerk to attest to this vacation of parts of Glenn Drive for and in the name of the Village.
