And whereas it has been and hereby is ascertained and declared that the total amount of appropriations for all corporate purposes legally made and to be collected from the tax levy for the fiscal year amounts to \$46,360.00.

And whereas it now appears desirable to the Board of Trustees to reduce the amount to be levied and assessed for corporate purposes; now, therefore,

Be it ordained by the Board of Trustees of the Village of Chatham, Illinois, as follows:

Section One. For general corporate purposes, the sum of \$46,360.00 is hereby levied and assessed for the fiscal year ending April 30, 1970, upon all property subject to taxation within the corporate limits of the Village of Chatham, as the same is equalized and assessed for state and county purposes in the following amounts and for the particular objects and purposes hereinbefore specified in the appropriation ordinance, and now again specified as follows:

Section Two. Warrants, against and in anticipation of the above levied taxes for the payment of expenses and outlays of the village for corporate purposes for the current year, are hereby authorized to be drawn by the President and the Village Clerk and endorsed by the Village Treasurer to the extent of seventy five percent (75%) of the amount of said taxes.

Section Three. The Village clerk shall file forthwith in the office of the County Clerk of Sangamon County, Illinois, a certified copy of this ordinance which shall be in lieu of any former levy ordinances for the current fiscal year, and the County Clerk shall ascertain the rate percent upon which the total value of all property subject to taxation within the Village of Chatham, as the same is assessed and equalized for state and county purposes for the current fiscal year will produce the net amount herein levied and ordered certified, and the County Clerk shall extend the tax on the tax books of the Collector of state and county taxes within the village as provided by law.

Section Four. This ordinance shall take effect and be in full force from and after its passage, signing and approval, and all ordinances and parts of ordinances in conflict herewith are repealed.
