AN ORDINANCE ANNEXING TERRITORY OWNED BY ADA JOSEPHINE AXLINE AND JEROME A. ROBINSON TO THE VILLAGE OF CHATHAM

WHEREAS, Jerome A. Robinson and Ada Josephine Axline have filed a petition requesting annexation of certain territory to the Village of Chatham; and,

WHEREAS, said petition recites that Ada Josephine Axline is the owner of said territory and Jerome A. Robinson has entered into a contract to purchase said territory; and that said territory contiguous to the Village of Chatham and is not within the corporate limits of any other municipality, and that no electors reside on said territory; and,

WHEREAS, said petition for annexation provides that it is conditioned upon the described territory being classified under any present or future zoning ordinance of the Village of Chatham for such uses as are now permitted under the R-3 Zoning District Regulations of the Sangamon County Zoning Ordinance, which are comparable to the provisions of the R-3 Zoning District of the Village of Chatham as set forth in the Village of Chatham zoning ordinance, effective June 20, 1971; and,

WHEREAS, Jerome A. Robinson and Ada Josephine Axline filed a petition requesting such R-3 zoning classification for said territory, and on March 9, 1972, a public hearing was held before the Plan Commission of the Village of Chatham, Illinois, pursuant to notice duly published in a newspaper having a general circulation within the Village of Chatham, and following said public hearing the Plan Commission

of the Village of Chatham voted in favor of classifying said territory as part of the R-3 Zoning District of the Village of Chatham; and,

WHEREAS, on February 4, 1972, notice was mailed by certified mail, return receipt requested, to Trustees of the Chatham Community Fire Protection District, c/o William C. Skaggs, 608 South Grand, Chatham, Illinois, notifying said trustees of the Chatham Community Fire Protection District that the Board of Trustees of the Village of Chatham, would consider the question of passage of an ordinance annexing the described territory to the Village of Chatham;

Therefore, Be It Ordained by the President and Board of Trustees of the Village of Chatham in Sangamon County, Illinois:

Section 1. Pursuant to the petition for annexation filed by Jerome A.

Robinson and Ada Josephine Axline, the following described territory is hereby annexed to the Village of Chatham, Illinois:

The Southeast Quarter of the Southeast Quarter of Section 8, Township 14 North, Range 5 West of the Third Principal Meridian, in Sangamon County, Illinois, except approximately 12 acres off the East end thereof, conveyed to the City of Springfield;

Also the North 80 feet of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of Section 17, Township 14 North, Range 5 West of the Third Principal Meridian, all in Sangamon County, Illinois.

Section 2. The new corporate limits of the Village of Chatham shall extend to the far side of any and all highways adjacent to the above-described territory.
