ANNEXATION ORDINANCE (VILLAGE OF CHATHAM, ILLINOIS)

There having been filed with the required authorities and the Village Clerk of the Village of Chatham, Illinois, a Petition duly verified praying that certain territory described therein be annexed to the Village of Chatham, Illinois, and stating that the territory described therein is contiguous to the Village of Chatham, Illinois; and that none of the territory described therein is within the corporate limits of the Village of Chatham; and that none of the territory described therein is within the corporate limits of any municipality; and that the Petitioners, WALTER G. LUEDKE, CARRIE H. LUEDKE, GERTRUDE M. STEFFEN and ESTHER RATZ are the owners of the premises described in the Petition and that WALTER C. LADAGE and JACQUELINE J. LADAGE are the only persons residing on said territory and are all the electors residing therein.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS:

Section 1. That the territory described as:

Part of the East $\frac{1}{2}$ of the Southeast Quarter of Section 1 and part of the Northeast Quarter of the Northeast Quarter of Section 12 in Township 14 North, Range 6 West; and part of the West $\frac{1}{2}$ of the Southwest Quarter of Section 6, Township 14 North, Range 5 West of the Third Principal Meridian in Sangamon County, Illinois, more particularly described as follows:

Commencing at the Southwest corner of the aforesaid Section 6; thence North $89^{\circ} 12'$ East, a distance of 31.20 feet to the East R. O. W. line of Illinois Route 4; thence North $0^{\circ} 47'$ West along said East R. O. W. line, a distance of 537.18 feet; thence North $0^{\circ} 48'$ West along said East R. O. W. line, a distance of 1077.70 feet; thence North $90^{\circ} 00'$ West, a distance of 550.00 feet; thence South $0^{\circ} 13' 44''$ West, a distance of 2204.15 feet to the existing corporate limits of Chatham; thence North $89^{\circ} 58' 46''$ East along said corporate limit line, a distance of 550.00 feet; thence North $0^{\circ} 00'$ East, a distance of 588.77 feet to the point of beginning. Said tract contains 28.349 acres, more or less.

All the foregoing situated in Sangamon County, Illinois, being the property described in Exhibit A of the Petition for Annexation; be and it is hereby annexed to the Village of Chatham, Illinois. Said property to be zoned R-1.
