AN ORDINANCE RELATING TO TRAFFIC STOP INTERSECTIONS AND SIGNS

WHEREAS, the Village of Chatham Board of Trustees has employed a firm of Traffic Engineers to complete a study for sign inventory for the Village in order to facilitate the free flow of traffic and to insure safety to the motoring public and based on such study, the Village Board of Trustees has determined that it is in the public interest to designate a number of new stop intersections in the Village and erect stop signs thereat; now, therefore,

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS:

Section 1. Stop Intersections and Signs.) No person shall drive any vehicle into the intersections of the following named streets without bringing the vehicle to a full stop and waiting for the traffic to clear on the street with the right-of-way:

Appropriate stop signs shall be posted at all such intersections.

Section 2. Penalty.) Any person convicted of a violation of failing to stop, as required by this ordinance, at a stop sign shall be punished by a fine of not less than \$5.00 nor more than \$200.00.

Section 3. Effective Date.) This ordinance shall take effect and be in full force from and after its passage and 10 days after publication as provided by law.
