

ORDINANCE NO. 76-11

AN ORDINANCE ESTABLISHING PREVAILING RATE OF WAGES FOR VILLAGE OF CHATHAM.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, THAT:

Section 1. Pursuant to investigation, it is hereby ascertained that the prevailing rate of wages in the Village of Chatham as of June 24, 1976, is the prevailing rate of wages for construction work in Sangamon County area on June 24, 1976, as heretofore ascertained by the State of Illinois Department of Labor. A copy of such prevailing rate of wages for construction work is hereto attached as Exhibit A and made a part of this Ordinance.

Section 2. The Village Clerk shall:

(a) Post a certified copy of this Ordinance in the Chatham Municipal Building;

(b) File a certified copy of this Ordinance in the Office of the Illinois Secretary of State, and

(c) Publish in the Chatham Clarion a certified copy of this Ordinance within 30 days.


