ORDINANCE 78-14

WHEREAS, the Board of Trustees of the Village of Chatham has adopted a plan for the installation of new sewage facilities which entails the construction and acquisition of certain sanitary sewer system and facilities within the boundaries of the Village District; and

WHEREAS, certain plans, routes, sites and locations for the placement of the said sanitary sewer system and facilities have been prepared and adopted by the Village of Chatham; and

WHEREAS, certain rights of way and permanent and temporary construction easements along, over, upon, beneath and across on said routes, sites and locations are necessary convenient and desirable to be acquired by the Village of Chatham to construct said sanitary sewer system and facilities in the public interests; and

WHEREAS, certain easements plats have been prepared showing the locations of the various rights of way required to be acquired as aforesaid, the legal descriptions of which said rights of way, permanent and construction easements are described on Exhibit A, attached hereto and made a part hereof;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. That the Plan for the installation of new sewer facilities as described hereinabove shall be implemented and such sewer facilities constructed in the public interest.

Section 2. It is further hereby determined that it is necessary, convenient and desirable that the Village of Chatham shall acquire the rights of way, permanent and temporary construction easements as shown on Exhibit A, attached hereto.

Section 3. That the Board of Trustees of the Village of Chatham be and it hereby is authorized, impowered and directed to determine and ascertain the compensation that shall be offered for said rights of way, permanent and temporary construction easements to the owner or owners thereof, and it and their duly designated representatives are further authorized and directed to negotiate with the owner or owners of the real estate described on Exhibit A for the acquisition of the rights described in paragraph 2 of this Ordinance.

A STATE OF THE STA

Section 4. In the event that the Village of Chatham is unable to agree with the owner or owners of the real estate described in Exhibit A as to the compensation to be paid for such rights of way, permanent and temporary construction easements as described in paragraph two (2) herein, then the right of way, permanent and temporary construction easements shall be acquired by the Village of Chatham pursuant to the provisions of the State of Illinois, and the law of eminent domain of the State of Illinois, and Giffin, Winning, Lindner, Newkirk, Cohen & Bodewes is hereby authorized, empowered and directed to institute proceedings in any court of competent jurisdiction to acquire the rights of way, permanent and temporary construction easements described in paragraph two (2) herein in accordance with the eminent domain laws of the State of Illinois.

Section 5. The Ordinance shall take effect and be in full force from and after its passage and approval.
