

ORDINANCE NO. 78-29a

AN ORDINANCE AUTHORIZING THE ADVERTISEMENT FOR AND THE TAKING OF BIDS FOR INSTALLATION OF SEWERS AND RELATED IMPROVEMENTS FOR SECTIONS "A THROUGH D" FOR THE CHATHAM MUNICIPAL SEWER SYSTEM.

WHEREAS, The electors of Village of Chatham heretofore have be referendum approved the installation of the Chatham Municipal Sewer System, and

WHEREAS, Easements, Rights-of-way and Permits for Sections "A through D" have been acquired, and

WHEREAS, All engineering and bid specifications have been completed and approved by the State of Illinois Environmental Protection Agency, and

WHEREAS, it is necessary and convenient that Village of Chatham undertake to advertise for and receive bids for the installation of sewers.

NOW THEREFORE BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Chatham as follows:

Section 1. Plans, Specifications and Contract Documents for Chatham Municipal Sewer System Sections "A through D" prepared by Benton and Associates, Inc., Consulting Engineers, Jacksonville, Illinois, of which one set of the Plans, Specifications and Contract Documents are on file in the Village Hall of the Village of Chatham, Illinois and heretofore approved by the Environmental Protection Agency of the State of Illinois, Construction Permit No. #1977-HA-4054-1, be and the same duly are approved and adopted as the official Specifications and Plans for such Sections of the Chatham Mucincipal Sewer System.

Section 2. The Village of Chatham be and it hereby is authorized and directed by and through Benton and Associates, Inc., of Jacksonville, Illinois, its Consulting Engineers to advertise and publish on behalf of the Village of Chatham for sealed bids for the installation of sewers and related improvements for Sections "A through D" for the Chatham

Municipal Sewer System pursuant to the Plans, Specifications and Contract Documents prepared by Benton and Associates, Inc., all of which are incorporated herewith and made a part of this Ordinance.

Section 3. Sealed Bids for the construction of Sections "A through D" of the Chatham Municipal Sewer System will be received by the Village of Chatham, Illinois at the office of Village Clerk, Village Hall, Chatham, Illinois until 11:30 a.m. <sup>Central Standard</sup> ~~Daylight Savings~~ Time November 27, 1978, and then at said office publicly opened and read aloud.

Any Contract or Contracts awarded under this Invitation for Bids are expected to be funded in part by a grant from the Illinois Anti-Pollution Fund. Neither the State of Illinois nor any of its Departments, Agencies or employees is or will be a party to this Invitation for Bids or any resulting Contract.

The Contract Documents, consisting of Advertisement for Bids, Information for Bidders, Bid, Bid Bond, Agreement, General Conditions, Special Provisions, Payment Bond, Performance Bond, Notice of Award, Notice to Proceed, Change Order, Compliance Statement, Equal Employment Opportunity Clause, Drawings, Specifications and Addenda, may be examined at the following locations:
