## ORDINANCE NO. 82-18

WHEREAS, it is deemed advisable, convenient and necessary for the best interests of the residents of the Village of Chatham, Sangamon County, Illinois, in order to improve a portion of its electric distribution system in and for said Village, that the Village contract for work to be done, including the furnishing of all necessary labor, tools, equipment, materials, supplies and miscellaneous items required therefor, to convert the area in West Chatham from 2.4/4.16 kV to 7.2/12.5 kV along with other improvements as directed; and

WHEREAS, the Village has advertised for bids for the providing of such work and furnishing of such materials, pursuant to and in accordance with the plans and specifications dated May, 1982, and prepared by C. H. Guernsey & Company, Consulting Engineers and Architects of Oklahoma City, Oklahoma, such advertisements having appeared in the legal notices section of the State Journal-Register and Chatham Clarion, newspapers of general circulation in Sangamon County, Illinois, advertising that sealed bids for such work and furnishing of such materials would be opened in the Village Hall, 117 East Mulberry Street, Chatham, Illinois, on May 27, 1982, at the hour of 7:00 o'clock P.M.; and

WHEREAS, in response thereto sealed bids were received and opened as aforesaid; and
