

ORDINANCE NO. 85-1

AN ORDINANCE PROVIDING FOR THE CORPORATE AUTHORITIES OF THE VILLAGE OF CHATHAM TO EXECUTE A CONTRACT WITH THE CORPORATE AUTHORITIES OF THE SPRINGFIELD SANITARY DISTRICT AMENDING THE CONTRACT BETWEEN SAID VILLAGE AND SANITARY DISTRICT DATED APRIL 13, 1976, AS AMENDED.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, as follows:


Section 1. The corporate authorities of the Village of Chatham, Sangamon County, Illinois, be and they hereby are authorized and directed to execute a contract with the corporate authorities of the Springfield Sanitary District, Sangamon County, Illinois, amending the contract between said Village and Sanitary District dated April 13, 1976, as amended, in the form and style of the contract attached hereto.

Section 2. All ordinances, resolutions and parts thereof in conflict herewith be and the same hereby are repealed.


Section 3. This Ordinance shall be effective upon passage and approval as provided by law.

AN ORDINANCE OF THE SPRINGFIELD SANITARY DISTRICT
AUTHORIZING AMENDMENT OF A CERTAIN CONTRACT BETWEEN
SAID DISTRICT AND THE VILLAGE OF CHATHAM, ILLINOIS

WHEREAS, the Springfield Sanitary District and the Village of Chatham, Illinois have heretofore entered into a certain contract dated April 13, 1976 as recited in the introductory paragraph of the attached Exhibit A; and,

WHEREAS, said contract has been amended on September 1, 1980 and on July 26, 1983 in order to conform to subsequent agreements of the parties regarding collection fees; and,

WHEREAS, certain amendments to the contract as amended are now necessary; and,

WHEREAS, the attached Exhibit A recites those necessary changes.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Springfield Sanitary District that the President and the Clerk of said Board are hereby authorized to execute the amendment to said contract in manner and form as shown in the attached Exhibit A and that the said amendment be effective on and after August 1, 1984.



AMENDMENT TO A CONTRACT BETWEEN
THE SPRINGFIELD SANITARY DISTRICT
AND THE VILLAGE OF CHATHAM, ILLINOIS

IT IS HEREBY AGREED on this 8 day of January, 1985, by and between the Springfield Sanitary District, hereinafter called "District" and the Village of Chatham, Illinois hereinafter called "Chatham", that Paragraph 6 of the original Contract and Paragraph 15 of the Amendment to said Contract dated July 26, 1983 between said District and Chatham to be amended to read as follows:

6. The Water Department of the Village will, as agent for the District, bill all District water and sewer users outside the Village who are served by the Water Department of the Village and from whom no other municipality is collecting sewer charges under contract with the District, at the rates and under the terms and conditions set by the District and will undertake the collection of the District's charges from such users. It will pay over monthly to the District all amounts so collected, less \$0.50 per bill, collecting such charges. Upon written notice by either party to the other at least ninety (90) days before the expiration of any year of collection of sewer service charges under this contract, said charge for collection may be reviewed in light of the actual expenses incurred by the Department, in such service to the District; and if an adjustment cannot be agreed upon, the Department shall, from the beginning of the next year of operation, make available to the District, the water meter readings on sewer users outside the Village from whom no

other municipality is collecting sewer charges under contract with the District, and may furnish any part of the billing or collecting service for the District for which compensation to it may be agreed upon, but shall no longer be required to bill and undertake to collect the sewer service charges of the District as its agent.

15. A. The District will accept all payments paid by the Village from February 1980, through September 15, 1980, as being correct and proper and no additional payments are due for this period.

B. The District will accept the information on the number of sewer users within the Village for each month from October 15, 1980, through December 15, 1982, as prepared by Clifford N. Kevern as being correct and accurate.

C. No additional amounts as stated in number 15.A. above are owed by the Village, which reduces the total for 1980, 1981 and 1982 from \$42,400.50 to a revised total of \$35,292.00. Further, this amount is to be reduced by \$1,414.75, which is overpayments for the first three months of 1983. The final revised amount owed through March 15, 1983, is \$33,877.25.

D. The Village will make monthly payments to the District beginning June 15, 1983 as follows:

District Sewer Charge = \$0.1738 per 1,000 gallons of billable flow.

Plus Service Charge = \$1.00 per month per sewer user
(Village not to retain \$0.25 per user).

Plus \$1,500.00 per month.

Said monthly payments shall continue until delinquent amount

of \$33,877.25 is paid in full. Thereafter said payments to be as follows:

District Sewer Charge = \$0.1738 per 1,000 gallons of billable flow.

Plus Service Charge = \$0.50 per month per sewer user.

Each month the Village shall furnish to the District the number of sewer users and quantity of billable flow.

E. The District will not require the Village to pay interest for the period when the money is owed (said interest amounting to more than \$5,000.00) if the above schedule is adhered to.

AMENDMENT TO A CONTRACT BETWEEN
THE SPRINGFIELD SANITARY DISTRICT
AND THE VILLAGE OF CHATHAM, ILLINOIS

IT IS HEREBY AGREED on this 8 day of January, 1985, by and between the Springfield Sanitary District, hereinafter called "District" and the Village of Chatham, Illinois hereinafter called "Chatham", that Paragraph 6 of the original Contract and Paragraph 15 of the Amendment to said Contract dated July 26, 1983 between said District and Chatham to be amended to read as follows:

6. The Water Department of the Village will, as agent for the District, bill all District water and sewer users outside the Village who are served by the Water Department of the Village and from whom no other municipality is collecting sewer charges under contract with the District, at the rates and under the terms and conditions set by the District and will undertake the collection of the District's charges from such users. It will pay over monthly to the District all amounts so collected, less \$0.50 per bill, collecting such charges. Upon written notice by either party to the other at least ninety (90) days before the expiration of any year of collection of sewer service charges under this contract, said charge for collection may be reviewed in light of the actual expenses incurred by the Department, in such service to the District; and if an adjustment cannot be agreed upon, the Department shall, from the beginning of the next year of operation, make available to the District, the water meter readings on sewer users outside the Village from whom no

other municipality is collecting sewer charges under contract with the District, and may furnish any part of the billing or collecting service for the District for which compensation to it may be agreed upon, but shall no longer be required to bill and undertake to collect the sewer service charges of the District as its agent.

15. A. The District will accept all payments paid by the Village from February 1980, through September 15, 1980, as being correct and proper and no additional payments are due for this period.

B. The District will accept the information on the number of sewer users within the Village for each month from October 15, 1980, through December 15, 1982, as prepared by Clifford N. Kevern as being correct and accurate.

C. No additional amounts as stated in number 15.A. above are owed by the Village, which reduces the total for 1980, 1981 and 1982 from \$42,400.50 to a revised total of \$35,292.00. Further, this amount is to be reduced by \$1,414.75, which is overpayments for the first three months of 1983. The final revised amount owed through March 15, 1983, is \$33,877.25.

D. The Village will make monthly payments to the District beginning June 15, 1983 as follows:

District Sewer Charge = \$0.1738 per 1,000 gallons of billable flow.

Plus Service Charge = \$1.00 per month per sewer user
(Village not to retain \$0.25 per user).

Plus \$1,500.00 per month.

Said monthly payments shall continue until delinquent amount

of \$33,877.25 is paid in full. Thereafter said payments to be as follows:


District Sewer Charge = \$0.1738 per 1,000 gallons of billable flow.

Plus Service Charge = \$0.50 per month per sewer user.

Each month the Village shall furnish to the District the number of sewer users and quantity of billable flow.

E. The District will not require the Village to pay interest for the period when the money is owed (said interest amounting to more than \$5,000.00) if the above schedule is adhered to.


