WHEREAS, the territory is, prior to its annexation, and after its annexation will yet be, in both the Chatham Fire Protection District and the Chatham Library District, the Village providing no separate fire protection or library services, and accordingly no notice of this annexation proceeding is required to be given to either of those bodies; and

WHEREAS, said territory encompasses, or is adjacent to, and therefore by law will include within the territory annexed to the Village a certain Township Road running South from the present corporate limits of the Village of Chatham along the Easterly section line of Section 24 Township 14 North, Range 6

SECTION 3: The Village Clerk is hereby directed to record with the Sangamon County Recorder of Deeds and to file with the County Clerk of Sangamon County a certified copy of this Ordinance together with an accurate map of the territory annexed appended to said Ordinance.
