WHEREAS, the Village of Chatham needs consulting services in regard to the matter of negotiating a long term wholesale power contract with the Illinois Municipal Electric Agency or some other supplier;

WHEREAS, therefore, it is in the best interest of the Village to retain Foster & Associates of Washington, D.C. to advise it with respect to negotiating such a long term power contract.

Dear John:

Foster Associates would be pleased to provide assistance to the Village of Chatham, Illinois in connection with the negotiation of a power purchase contract. It is our understanding that the Village is presently considering a 35-year power sales contract with the Illinois Municipal Electric Agency (IMEA). The purpose of our assignment would be to identify any other options which the village may have and present this data for review along with the aforementioned IMEA contract.

Perhaps the assignment could be best handled on a multi-step basis. The initial phase would consist of a review of existing power sources that may be available for the village. We would then solicit and, when received, analyze any offers obtained from such agencies, both public and private. The terms of these offers would be compared to the contract offered by IMEA on the basis of price and other collateral information available without extensive research. It is possible that a report for the Village, at this point, would be adequate for the decision-making process. If not, further work could be carried out if approved by the village.

It is difficult to ascertain the scope of an assignment such as this prior to the completion of an initial phase investigation. If suitable alternatives are uncovered, the assessment of long-term risks in terms of future price changes may suggest a forecast of the cost of power for a period into the future under both the IMEA and such other alternatives. Such a forecast could result in an additional work effort.

Estimate of Charges

Our usual method of billing for services is on the basis of time and material. We will exert every effort to complete the project for less than the estimated amount. Expenses are billed at a cost plus five percent. Hourly rates used in computing charges for the services of the principal staff are as follows:

Senior Consultant	\$175-200
Consultant	75-100
Analysts	45-60
Junior Personnel	25-45

We would expect to contain the charges for the initial phase of this work within the limits of \$12,000 to \$18,000 except as unforeseen circumstances might enlarge the scope of what we have to do. We would begin work within one week of authorization and would expect to complete the assignment within a specified time frame.
