THIS CONTRACT is between the Village of Chatham, Illinois, an Illinois municipal corporation, and Jared and Jack Lauderback, d/b/a Lauderback Mowing Service and is dated this ____ day of April, 1991.

- to mow and trim the old Chatham Cemetery and the new Chatham Cemetery inside the Ring Road, a total of approximately 5.5 acres, during the term of this contract. Mowing and trimming shall be conducted as determined by Lauderback in its discretion to maintain grass and weeds so the appearance is alluring to the public and a maximum of four inches in height.
- 2. For its services, Lauderback shall be paid as follows: \$500 per mowing and \$300 per trimming.
- 3. While Lauderback shall have discretion as to when to mow and trim, the Village field technician shall have final authority, and may instruct Lauderback to mow and trim for special occasions. In such event, Lauderback shall mow and trim within two days of a request of the Village field technician.
- 4. This contract shall be effective beginning April 1, 1991, and ending October 15, 1991.
