Ordinance No. 91-51

AN ORDINANCE VACATING AN ALLEY

WHEREAS, pursuant to Section 11-91-1 of the Illinois
Municipal Code, whenever the corporate authorities of any
municipality determine that the public interest will be subserved
by vacating any or alley or part thereof within their
jurisdiction in any incorporated they may vacate the alley by
ordinance;

WHEREAS, such an ordinance must be passed by the affirmative vote of at least 3/4 of the trustees then holding office;

WHEREAS, the corporate authorities find it to be in the public interest to vacate that certain alley located in the Village of Chatham which runs north to south and is within the block bounded by Mulberry, College, Chestnut and Taylor Streets and is bounded to the north by Mulberry Street and to the south by Chestnut Street (the "Alley");

WHEREAS, the corporate authorities find that the benefits accruing to the property owners abutting the Alley are minimal and that therefore it is unnecessary for the abutting property owners to pay any compensation;

WHEREAS, the corporate authorities find that there are no public service facilities in the Alley.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The findings in the preamble hereto are hereby adopted.

SECTION 2:

The Alley is hereby vacated.

SECTION 3:

The Village Administrator shall mail a copy

of this Ordinance to persons whose property abuts the Alley, specifically, lots 5 and 12 of the West Park Addition to the Village of Chatham, and three lots which are comprised in part of lots 4 and 13 of the West Park Addition to the Village of Chatham.

SECTION 4: The Clerk shall file a copy of this Ordinance with the Recorder of Deeds of Sangamon County, Illinois.
