Ordinance No. 92-07

AN ORDINANCE ANNEXING CERTAIN LAND TO THE VILLAGE OF CHATHAM, ILLINOIS

WHEREAS, on February 18, 1992, a Petition for Annexation pursuant to Section 7-1-8 of the Illinois Municipal Code was filed by Phyllis Summers with the corporate authorities of the Village of Chatham, Illinois;

WHEREAS, the property sought to be annexed is legally described as set forth in Exhibit A to this ordinance and as shown in a Plat of Annexation attached to this Ordinance as Exhibit B;

WHEREAS, the Petition for Annexation states that the Petitioners comprised 100% of the owners of record of the land sought to be annexed and that either no electors reside on the territory or that the Petitioner's comprise 100% of the electors in said territory.

WHEREAS, the land proposed to be annexed includes a highway under the jurisdiction of the Village of Chatham and the petitioner grants Roadway Easement as shown in Exhibit C;

WHEREAS, the Village of Chatham does not provide fire protection or a public library, such that the Trustees of the Chatham Fire Protection District and Chatham Public Library District need not be served with notice;

WHEREAS, the corporate authorities of the Village of Chatham find it to be in the best interest of the Village of Chatham to annex the territory.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The territory, the legal description of which is attached hereto as Exhibit A, is hereby annexed to the Village of Chatham.

SECTION 2: This ordinance is effective immediately.

SECTION 3: The Village Clerk shall forthwith cause this Ordinance to be recorded with the Recorder of Deeds of Sangamon County and with the County Clerk of Sangamon County.

PLAT OF ANNEXATION TO THE VILLAGE OF CHATHAM




EXHIBIT C

ROADWAY EASEMENT

In consideration of the annexation of the property legally described herein to the Village of Chatham, Illinois, ("Grantee"), the undersigned Grantor (s) Phy//is Summers

hereby grant(s) and convey(s) to Grantee, a roadway right-of-way and incidents to it for a public highway, the $\underline{\textit{Wsit}}$ 40 feet of the property legally described in Exhibit A hereto.

Grantor(s) further grant(s) to Grantee within said right-of-way the right to lay out, open, establish, construct, extend, widen, straighten, maintain, grade and improve any public highway, bridge, or slopes necessary to retain and support any such highway, together with all ditches, pipes, culverts, and other drainage facilities as are deemed appropriate in the opinion of the Grantee to drain such highway or adjacent property.

Grantor(s) further grant(s) to Grantee the right to construct, extend and maintain any utility lines owned by Grantee, including but not limited to water, sewer, electric and television cable lines, within the roadway.

Grantor(s) further agree(s) that this roadway easement shall run with the land and shall be binding upon Grantor(s), his/her/their heirs, successors, and assigns forever.
