
**AN ORDINANCE AMENDING THE VILLAGE OF CHATHAM ZONING

VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:


**SECTION 1:** Section V(D)(1)(b)(2) of the Zoning Ordinance
