## Ordinance No. 94-70

AN ORDINANCE AMENDING SECTION 17.1 OF THE 1994 LAND SUBDIVISION ORDINANCE OF THE VILLAGE OF CHATHAM, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Section 17.1 of the 1994 Land Subdivision Ordinance of the Village of Chatham is amended to state as follows:

SECTION 17.1: Construction Plans in the Event There is More Than One Final Plat.

Notwithstanding anything else in this Ordinance to the contrary, whenever the subdivider anticipates more than one final plat arising from an approved preliminary plan, the subdivider shall submit, along with the construction plans for the first final plat, the drainage and detention plans for each watershed that is affected by the construction of all bolats. If a watershed is partially affected by any final plat, then the subdivider shall submit drainage and detention plans for the entire watershed irrespective of whether the watershed is located partially outside the plat. No final plat shall be approved until all construction work completed, or security is given construction, of drainage and detention works for all watersheds affected by the final plat. Until all drainage works for the entire subdivision are built, provisions shall be made in the construction plans if necessary for temporary detention works for each plat as each plat is built.

SECTION 2: This Ordinance is effective on its passage and publication as required by law. The Clerk shall publish this Ordinance in pamphlet form. When the Clerk shall publishes the revised Subdivision Ordinance book mandated by Ordinance 94-60, she shall include this amendatory ordinance therein.
