Commencing at an iron pin marking the Southwest corner of the aforementioned Section 1, thence South 89 degrees 58 minutes 16 seconds East along the section line a distance of 1732.50 feet to an iron pipe, thence North 00 degrees 02 minutes 10 seconds East a distance of 117.90 feet to an iron pipe, thence South 89 degrees 58 minutes 16 seconds East a distance of 227.91 feet to an iron pipe, thence North 00 degrees 02 minutes 10 seconds East a distance of 261.34 feet to an iron pipe marking the true beginning, thence continuing North 00 degrees 02 minutes 109 seconds East a distance of 144.60 feet, thence South 89 degrees 57 minutes 50 seconds East a distance of 611.06 feet to a point on the Westerly Right-of-Way Line of Illinois Route 4, thence South 04 degrees 27 minutes 42 seconds West along said right-of-way line a distance of 145.03 feet to an iron pipe, thence North 89 degrees 57 minutes 50 seconds West a distance of 599.87 feet to the true point of beginning. WHEREAS, notice was given of the petition, the relief requested therein, the name of the petitioner and the time and place of the hearing by posting on petitioner's land, by publishing a notice thereof on in a newspaper published within the Village of Chatham, Illinois, and by giving written notice by mail to adjacent property owners, all as required in Section VIII (h)(3) of the Zoning Ordinance of the Village of Chatham;

WHEREAS, on 5/22/1995 the Village of Chatham Zoning Board of Appeals held a Public Hearing regarding the proposed rezoning and is unanimously recommending the rezoning be approved.

WHEREAS, the Village Board has reviewed the recommendation of the Zoning Board of Appeals and finds it to be in the best interest of the Village to rezone the Property.




