# AN ORDINANCE ANNEXING CERTAIN LAND TO THE VILLAGE OF CHATHAM, ILLINOIS AND ZONING IT IN ACCORDANCE WITH AN ANNEXATION AGREEMENT (BOYCE PROPERTY)

WHEREAS, on November 28, 1995, a Petition for Annexation pursuant to Section 7-1-8 of the Illinois Municipal Code and subject to an Annexation Agreement was filed by Patricia Smith Boyce;

WHEREAS, the property sought to be annexed is legally described as set forth in a Plat of Annexation attached to this Ordinance as Exhibit A;

WHEREAS, pursuant to the Annexation Agreement, which was approved by ordinance on November 30, 1995, the Village of Chatham agreed to zone the Property B-2, except the east 648.58 feet thereof, which the Village agreed to zone P-1 with a special use permit to permit the boarding of animals and for use as a kennel, as depicted on a zoning plat, Exhibit B hereto;

WHEREAS, the Petition for Annexation states that the Petitioner comprises all of the owners of record of the land sought to be annexed and that no electors reside on the territory;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: The territory, the legal description of which is attached hereto as Exhibit A, is hereby annexed to the Village of Chatham and zoned B-2 under the Zoning Ordinance of the Village of Chatham, except the east 648.58 feet thereof, which is zoned P-1 with a special use permit to permit the boarding of animals and for use as a kennel.

**SECTION 2**: This Ordinance is effective on its passage and approval as required by law.

**SECTION 3:** This annexation is subject to the terms and conditions of the aforedescribed Annexation Agreement.

<u>SECTION 4</u>: The Village Clerk shall forthwith cause this Ordinance to be recorded with the Recorder of Deeds of Sangamon County and with the County Clerk of Sangamon County, and shall send a copy by registered mail to the post office branch serving the territory.



