**AN ORDINANCE APPROVING AN AGREEMENT WITH JOHN D. ATCHISON**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** That certain agreement between the Village of Chatham and John D. Atchison pertaining to a water main easement and a water service line, a copy of which is attached hereto, is hereby approved.

**SECTION 2:** The President is authorized and directed to execute the attached contract on behalf of the Village, and the proper officers of the Village are authorized and directed to carry out the terms of said contracts.

**SECTION 3:** This Ordinance is effective immediately.

**AGREEMENT**

In consideration of the promise of John D. Atchison to grant an easement for water and other utility mains across his property legally described in Exhibit A hereto, such easement to be located in a 20 foot strip south of and immediately adjacent to Township Road 11 South, the Village of Chatham agrees to run a <sup>JDA 6 in</sup> 2 inch <sup>main</sup> water service approximately 400 feet in length from its main to be constructed in such easement, along the east roadway bed of Atchison Road on the west boundary of the property described in Exhibit A hereto, to the south of the bridge on Atchison Road. Said water service shall be constructed within 90 days of completion of the water main. *In consideration*
