

Ordinance No. 96-03

**AN ORDINANCE FIXING RATES AND CHARGES
FOR WATER AND WATER SERVICES FURNISHED BY THE
WATERWORKS SYSTEM OF THE VILLAGE OF CHATHAM, ILLINOIS**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: Section 5 of Ordinance No. 70-7, as amended, is further amended to state as follows:

SECTION 5: The following shall be the rates for water supplied through the waterworks system of the Village, payable monthly within 15 days after rendition of each bill.

<u>Volume</u>	<u>Inside Village Limits</u>	<u>In unincorporated Area</u>	<u>In Another Municipality</u>
Minimum 0-2,000 gal/month	\$8.50	\$11.10	\$13.32
All Over 2,000 gal/month	\$3.00 per 1,000 gal.	\$4.35 per 1,000 gal.	\$5.22 per 1,000 gal.

A separate minimum charge shall be made for each apartment, place of business or dwelling unit in all buildings containing two or more apartments, places of business or family units; however, no minimum charge shall be made for any vacant apartment, place of business or dwelling unit which is vacant during an entire month, provided that the water department has been notified in writing of such vacancy.

In addition to the foregoing rates, there shall be charged to the Chatham Fire Protection District the sum of \$22.00 per year for each fire hydrant connected to the waterworks systems for fire protection. This charge may be waived at the discretion of the Village President.

Further, the charge for bulk water sales shall be \$3.00 per 1,000 gallons.

The Village reserves the right to make changes in rates and conditions in its discretion and to establish further rules and regulations from time to time.

SECTION 2: Nothing in this Ordinance will be construed as giving any person located within another municipality the right to receive water services from the Village of Chatham. The Board reserves the right in its discretion to grant or deny such privilege.

SECTION 3: All other sections of Ordinance No. 70-7 and 82-22 currently in effect and not specifically modified or repealed by this Ordinance shall continue in effect.

SECTION 4: This Ordinance shall take effect with respect to bills due on or after March 1, 1996. The Clerk shall forthwith publish this Ordinance in pamphlet form.
