That the compensation rates set forth in Section 1 of this ordinance may be superseded by compensation rates set in any valid collective bargaining agreement between the village and a group of persons employed by the village or by any valid contractual agreement between the village and a person employed by the village.

SECTION 3. That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 4. That this ordinance shall be in full force and effect after its adoption and shall be retroactive to May 1, 1996.
