**Ordinance No. 96- 168**

**AN ORDINANCE ANNEXING CERTAIN LAND  
TO THE VILLAGE OF CHATHAM, ILLINOIS**

**WHEREAS**, on JUNE 12, 1996, a Petition for Annexation pursuant to Section 7-1-8 of the Illinois Municipal Code was filed by Alfred W. and Delores S. Ostermeier with the corporate authorities of the Village of Chatham, Illinois;

**WHEREAS**, the property sought to be annexed is legally described and as shown in a Plat of Annexation attached to this Ordinance as Exhibit A;

**WHEREAS**, the Petition for Annexation states that the Petitioner comprises all of the owners of record of the land sought to be annexed and that the Petitioner comprise at least 51% of the electors in said territory.

**WHEREAS**, the land sought to be annexed includes a highway under the jurisdiction of Ball Township, and proper notice of this annexation has been given to the Board of Trustees and Township Road Commissioner of said Township;

**WHEREAS**, the Village of Chatham does not provide fire protection or a public library, such that the Trustees of the Chatham Fire Protection District and Chatham Public Library District need not be served with notice;


**WHEREAS**, the corporate authorities of the Village of Chatham find it to be in the best interest of the Village of Chatham to annex the territory.

**SECTION 1:** The territory, the legal description of which is attached hereto as Exhibit A, is hereby annexed to the Village of Chatham.


**SECTION 2:** This Ordinance is effective on its passage and approval as required by law.

# PLAT OF ANNEXATION

Part of the Southwest Quarter of the Northeast Quarter of Section 30, Township 14 North, Range 5 West of the Third Principal Meridian, Sangamon County, Illinois, described as follows:

From the stone at the center of said Section 30, North on the Quarter Section Line 680.00 feet; thence East at right angles 100.00 feet to the point of beginning, thence continuing East 400.00 feet; thence North parallel to the Quarter Section Line 225.00 feet; thence West 265.00 feet; thence South 30 degrees 57 minutes 50 seconds West 262.39 feet to the point of beginning, containing 1.717 acres, more or less, all in the County of Sangamon, State of Illinois.
