AN ORDINANCE AMENDING "AN ORDINANCE PERTAINING TO LIQUOR CONTROL", ORDINANCE NO. 94-23

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The definition of "Restaurant" in Section 1 of Ordinance No. 94-23, "An

Ordinance Pertaining to Liquor Control", is amended to state as follows:

Restaurant. Any public place kept, used, maintained, advertised, and held out to the public as a place where meals are served, and where meals are actually and regularly served, without sleeping accommodations, such space being provided with adequate and sanitary kitchen and dining room equipment and capacity and having employed therein a sufficient number and kind of employees to prepare, cook and serve suitable food for its guests. Any business claiming to be a restaurant must document, on demand of the Liquor Commissioner, that 60% or more of its gross receipts during the past three months is derived from the sale of food as distinguished from alcoholic liquor.

SECTION 2: Section 22(A) of Ordinance No. 94-23, "An Ordinance Relating to Liquor

Control" is amended to state as follows:

Conditions of License.

(A) Closing hours.

1. It shall be unlawful for the holder of any license issued under this Ordinance, other than an R-1 or R-2 license located in an area zoned B-1 under the Chatham Zoning Ordinance, to sell or offer for sale at retail any alcoholic liquor in the Village during the following hours:

a. Monday through Saturday: 12:00 a.m. to 8:00 a.m.

b. Sunday: 12:00 a.m. to 12:00 p.m. and after 10:00 p.m.

2. It shall be unlawful for the holder of an R-1 or R-2 license located in an area zoned B-1 under the Chatham Zoning Ordinance, to sell or offer for sale at retail any alcoholic liquor in the Village during the following hours:

a. Monday through Thursday: 12:00 a.m. to 8:00 a.m. and after 10:00 p.m.

b: Friday and Saturday: 12:00 a.m. to 8:00 a.m. and after 11:00 p.m.

c: Sunday: 12:00 a.m. to 12:00 p.m. and after 10:00 p.m.

3. No licensee shall permit the consumption of alcoholic liquor by any person on the licensed premises after one-half hour after the time at which sales of alcoholic liquor are required by this Section to be terminated and before the time the licensee may next commence sales under this Section.

4. Class "P" (Package) licensees and Class "T" (Tavern) licensees shall cause the premises to be vacated within one-half hour after the time at which sales of alcohol are required by this section to be terminated and until the time the licensee may resume sales under this Section. All other licensees electing to remain open for other business during periods of time when the sales of alcoholic liquor are prohibited by this Section shall conspicuously post a notice stating that alcoholic liquor is not available for sale during such periods of time.

5. In addition, the holder of any license, regardless of classification, shall be permitted to sell or offer for sale at retail alcoholic liquor in the Village from the closing time established above for December 31 until the hour of 1:00 a.m. on January 1 in any year.

SECTION 3: This Ordinance is effective on July 1, 1996. The Clerk shall forthwith

publish it in pamphlet form and shall mail a copy to every holder of a liquor license issued by

the Village.
