Ordinance No. 97-32

AN ORDINANCE APPROVING THE FINAL PLAT OF SUBDIVISION OF CHATHAM BUSINESS PARK SUBDIVISION

WHEREAS, on June <u>5</u>, 1997 the Village of Chatham Planning Commission met and recommended approval of the final plat of subdivision of Chatham Business Park Subdivision, conditional upon receipt of the necessary highway access permit from the Illinois Department of Transportation;

WHEREAS, the Developer of Chatham Business Park Subdivision is in the process of negotiating an agreement whereby the public infrastructure improvements for the subdivision will be built using funds from the Chatham Downtown TIF District, and if such agreement is consummated, there will be no need for a bond or other security to secure the construction of such improvements;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The final plat of subdivision of Chatham Business Park Subdivision, and the covenants and documents thereto attached, are hereby approved, conditional upon the Developer thereof obtaining the necessary highway access permit from the Illinois Department of Transportation.

SECTION 2: The President is authorized and directed to sign said Plat on behalf of the Village upon presentation by the Developer of the necessary permit from the

Illinois Department of Transportation, and review and approval thereof by the consulting engineers for the Village.

SECTION 3: Surety for construction of the public improvements in Chatham Business Park Subdivision is hereby waived, pending negotiation and approval of a definitive agreement between the Developer and the Village regarding TIF funding of the infrastructure improvements. Should such an agreement not be approved within 60 days of this ordinance, then Developer shall provide such security upon demand of the Village. Upon the sale of any lot are prior to execution of an agreement providing for of TIF funding of the infrastructure improvements, Developer shall provide to the Village sufficient security to secure the portion of the infrastructure improvements attributable to such lot, which security shall be released upon the execution of the agreement.

<u>SECTION 4</u>: This Ordinance is effective immediately.
