**AN ORDINANCE APPROVING AGREEMENTS WITH ILEX SYSTEMS, INC
AND ELECTRIC LABORATORIES & SALES CORP. FOR THE PURCHASE
AND INSTALLATION OF A SCADA AND RECLOSER SYSTEM**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: Those certain contracts with Ilex Systems, Inc. and Electric Laboratories & Sales Corp. relating to the installation of a SCADA and Recloser system for the Village of Chatham Electric Department, dated November 1996, as modified by Change Orders No. 1 dated January, 1998, for contract prices of \$124,055.10 (Ilex) and \$43,713.10 (Electric Laboratories & Sales), are hereby approved.

SECTION 2: The Village President is hereby authorized to execute said contracts, and the proper officers of the Village are hereby authorized to carry out the contract according to their terms.


SECTION 3: This Ordinance is effective immediately.
