ORDINANCE NO. 98-17

AN ORDINANCE ACCEPTING BIDS FOR STORM DRAINAGE PROJECTS

WHEREAS, the Village of Chatham received a grant from the State of Illinois, administered through the Illinois Environmental Protection Agency, to address storm drainage issues in various areas of the village; and

WHEREAS, the Village advertised and obtained bids, which were opened at 1:00 p.m. on March 9, 1998 and the lowest responsible bidders identified, a summary of which is attached hereto and marked as Exhibit A; and

WHEREAS, on March 10, 1999 the Public Works Committee met to review the bids and is recommending the lowest bids from Petersburg Plumbing and Heating for contract "A" and the bid from Freesen, Inc. for contract "B". Contract "C" is not<sup>T-C</sup> be accepted at this time.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the bid from Petersburg Plumbing and Heating for \$331,391.59 on contract "A" and the bid from Freesen, Inc. for \$171,957.08 for contract "B" are hereby approved.


SECTION 2: The Village Administrator is hereby directed to complete the contract, notice of award and notice to proceed documents at the appropriate timing.

SECTION 3: This Ordinance is effective upon its passage and approval.
