
#### Gentlemen:

We hereby establish our IRREVOCABLE LETTER OF CREDIT NUMBER 403 in your favor for the account of Manor Hill Subdivision Plat III, and Charles E. Robbins and Maurice D. Tippett for the amount of Thirty-eight Thousand Five Hundred and no/100 dollars (\$38,500.00), available by your drafts at sight, drawn on Illini Bank, Springfield, IL accompanied by:

Except as otherwise expressly stated herein, this credit is subject to the Uniform Commercial Code as adopted in the State of Illinois.

We hereby agree with the drawers, endorsers and bona fide holders of drafts drawn under and in compliance with the terms of this Letter of Credit, that such drafts will be duly honored on due presentation to the drawee on or before September 29, 1999. All parties hereto agree that the outstanding obligation hereunder may be released only upon written authorization of the Engineer of said Village of Chatham. This Letter of Credit shall be automatically extended for additional periods of one year from the expiration date of each future expiration date unless sixty (60) days prior to such date, the Bank shall notify you in writing, by registered mail at the above address, that we elect not to renew this Letter

of Credit for such additional period. If we shall make such election, the Engineer of the Village of Chatham shall release Illini Bank of all further obligations under this Letter of Credit at the end of said 60-day period, provided however, that nothing contained herein shall be construed to limit the right of the Village of Chatham to make drafts against this Letter of Credit until its initial expiry date or any date to which said letter of credit is automatically extended as described above.
