AMENDMENT TO A CONTRACT BETWEEN  
THE SPRINGFIELD METRO SANITARY DISTRICT

IT IS HEREBY AGREED on this 26th day of January, 1999, by and between the Springfield Metro Sanitary District, hereinafter called "District" and the Village of Chatham, Illinois, hereinafter called "Chatham" as follows:

**Section 1:** That paragraph 5 of the Amendment to the Contract dated May 1, 1990 between said District and Chatham to be amended to read as follows:

5. The District will maintain and keep in effect a sewer user charge equivalent to charges paid by users of any Municipality in Sangamon County in the same rate class, based upon the quantity of water used as measured by the water meters on each lot, parcel of land, building or premises having any sewer connections which schedule has heretofore been adopted by said District. Each meter shall be considered a separate billing unit in applying the charges and rates.

**Section 2:** The District shall accept ownership of the Trunk Sewer as depicted on the Exhibit :A" attached hereto and transmit the sum of \$50,000 to the Village upon execution of this amendment.



WHEREAS, the Village of Chatham, Illinois ("Village") and the Springfield Metro Sanitary District ("District"), are units of government of the State of Illinois; and





5. 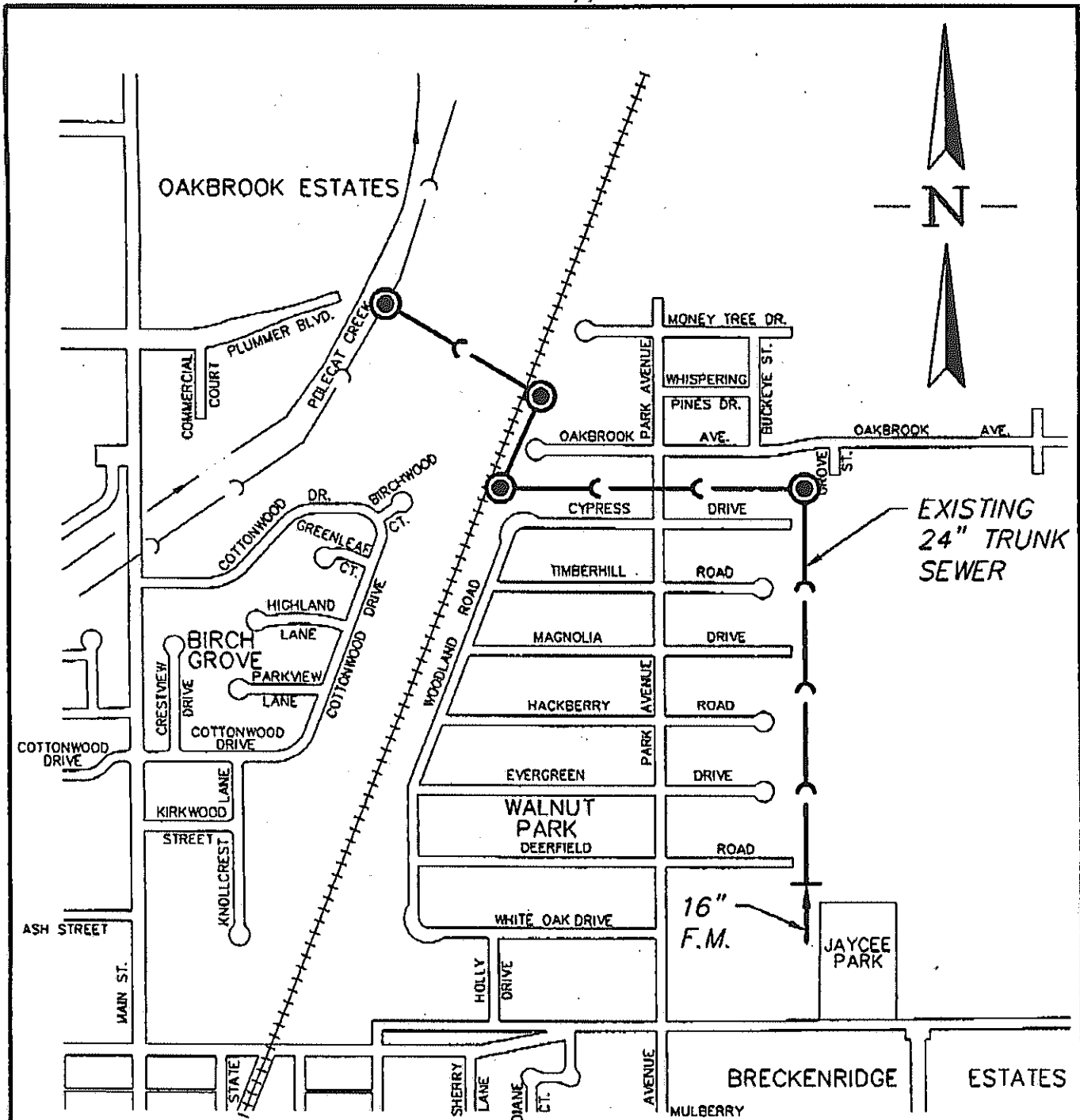

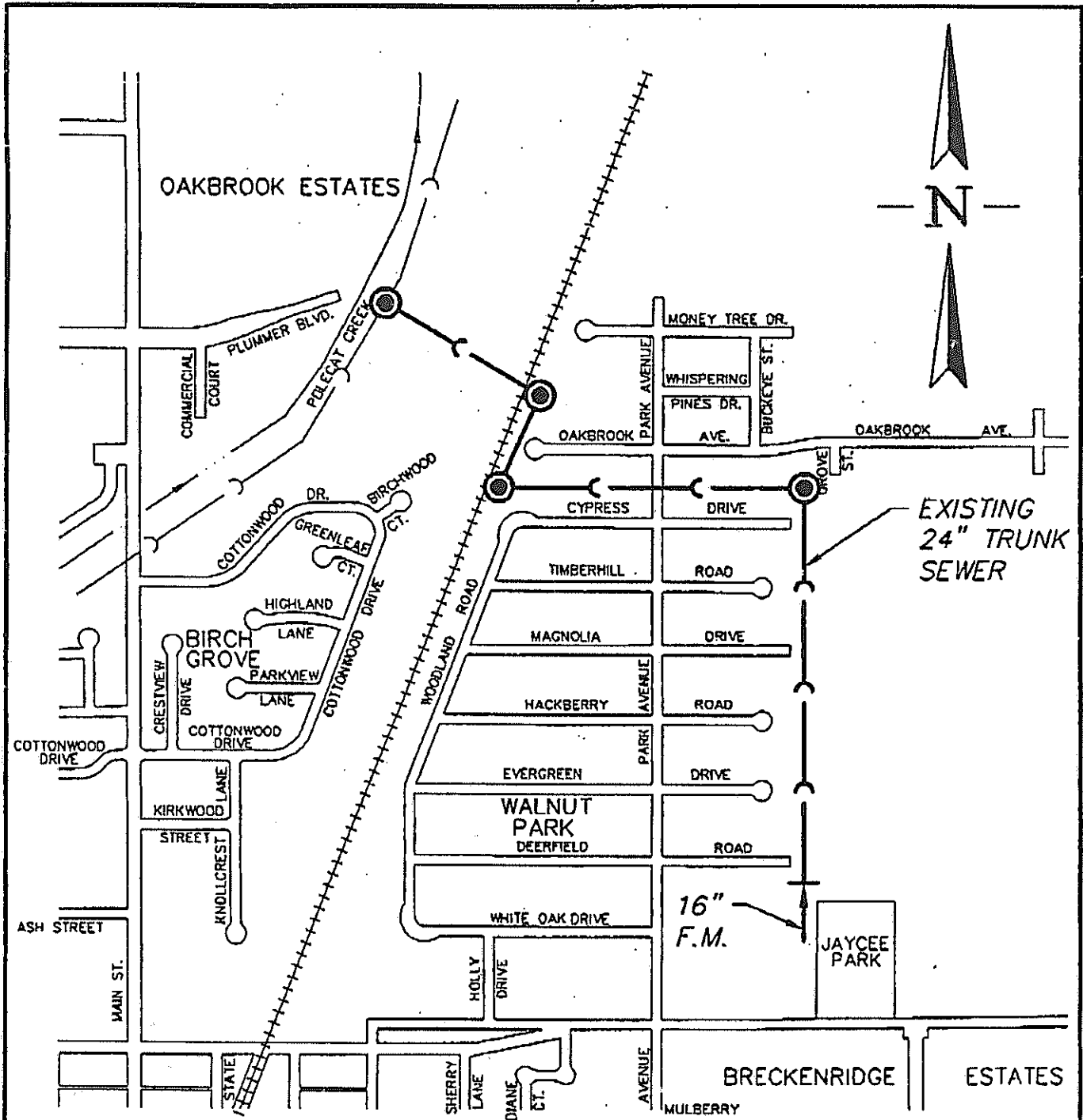
