## ORDINANCE NO. 99-49

## AN ORDINANCE ANNEXING DICK AND KATHY HUDDLESTON PROPERTY TO THE VILLAGE OF CHATHAM, ILLINOIS

WHEREAS, on October 20, 1999 a Petition for Annexation pursuant to Section 7-1-8 of the Illinois Municipal Code was filed by Dick and Kathy Huddleston with the corporate authorities of the Village of Chatham, Illinois; and


