AN ORDINANCE APPROVING A BID FOR A GAZEBO



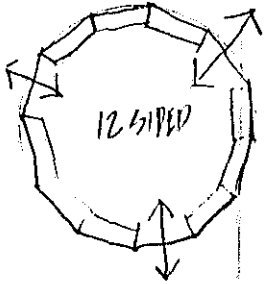


