AN ORDINANCE ACCEPTING A BID FOR WATER MAIN PROJECT ON WALNUT

WHEREAS, the Village advertised and obtained bids for the replacement of the twelve inch water main on Walnut Street from Gordon Drive through the Willow Glen subdivision, approximately 1820 feet, with an eighteen inch; with a six inch main to be abandoned; and

WHEREAS, the Public Works Committee met to review the bids and is recommending the lowest bid from Petersburg Plumbing and Heating for \$213,648.92.
