AN ORDINANCE APPROVING THE FINAL PLAT OF SUBDIVISION OF OAKBROOK ESTATES PLAT 8

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 2: Security in the amount of \$333,000 for construction of the public improvements in Oakbrook Estates Plat 8 is sufficient and is hereby approved. Letter of Credit No. 210-2709854, issued by Firstar Bank, is approved as surety therefor.


