ORDINANCE # 00 - 45

AN ORDINANCE IN REFERENCE TO SALARIES OF VILLAGE EMPLOYEES

WHEREAS, the following named person is to be employed by the Village of Chatham at the salary rate herein provided:

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the following named person shall be employed from the respective funds in the amount herein provided:

Name	Compensation Rate	Funding Distribution
Westerlund, Christine	13.650	General

SECTION 2: That the compensation rate set forth in Section 1 of this ordinance may be superseded by compensation rates set in any valid bargaining agreement between the village and a group of persons employed by the village or by any valid contractual agreement between the village and any person employed by the village.

SECTION 3: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such shall not affect the validity of the remaining portion of this ordinance.

SECTION 4: That this ordinance shall be in full force and effect as of the date of its adoption and shall be retroactive to May 1, 2000.


