## ORDINANCE $01-02$

AN ORDINANCE IN REFERENCE TO VILLAGE EMPLOYMENT

WHEREAS, the Police Department posted the position of Dispatcher on the department bulletin board and advertised the position in the Chatham Clarion; and

WHEREAS, the Police Department conducted interviews of potential candidates and is recommending the appointment of Patricia A. Brown, who has twenty years experience as a Dispatcher, is LEADS certified, and has experience with department software, as the preferred candidate.
