## ORDINANCE NO. 01-

### AN ORDINANCE REZONING REYNOLDS PROPERTY ON NORTH MAIN

WHEREAS, a petition for rezoning was filed by Larry Reynolds requesting the rezoning of the following real property located within the corporate limits of the Village of Chatham, Illinois (the "Property"): 1210 North Main Street, Chatham, Illinois.

WHEREAS, said petition requested rezoning of the Property from B-1 to B-2;

WHEREAS, notice was given of the petition, the relief requested therein, the name of the petitioner and the time and place of the hearing by posting on petitioner's land, by publishing a notice thereof on in a newspaper published within the Village of Chatham, Illinois, and by giving written notice by mail to adjacent property owners, all as required in Section VIII (h)(3) of the Zoning Ordinance of the Village of Chatham;

**WHEREAS**, on 1/29/2001 the Village of Chatham Zoning Board of Appeals held a Public Hearing regarding the proposed rezoning and is unanimously recommending the rezoning be approved.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: The findings in the preamble hereto are hereby adopted..

**SECTION 2:** The Property is hereby rezoned from its present zoning classification of B-1 to B-2.

**SECTION 3:** This Ordinance is effective upon its passage and approval.

## Zoning Board of Appeals January 29, 2001

Chairman Levine call the meeting to order at 7:05 P.M.

Chairman Levine stated that the purpose of this meeting was to look at the requested zoning for Larry Reynolds on Route 4 on the north side of Chatham.

Larry Reynolds spoke stating that all of the property around this property was B2 except for the Church which was B1. Larry also said that his property once was B2 but was rezoned by the board when Moore was President. Larry said that he would like to have the property rezoned to B2.

Paul Stivers asked Larry what the current use was.

Larry said the current use was grandfathered as a non-conforming use but was conforming when it was built.

Pat Boyce was concerned with non-conforming use but was hoping that Larry would go with the lower end of the B2 uses.

Chairman Levine ask if Pat was against the rezone.

Pat said that she was not against the rezone.

Chairman Levine said that business would look at Route 4 and Route 4 was the place for business.

Meredith asked Pat if her property was R05.

Pat said she had some R05.

Chairman Levine ask if Pat was going to look at B2 for her property.

Pat said that she would at some point in time.

David Johnson made a motion to approve the change from B1 to B2, second by John Stutsman.

Chairman Levine called for the vote.

Motion passed 4 yes 0 no.

Motion to adjourn by Paul Stivers, second by John Stutsman.

Motion approved by voice vote 4 yes 0 no.
