#### **AGREEMENT**

This agreement is between the Village of Chatham, Illinois ("Village") and Ball-Chatham Community School District No.5 ("District").

WHEREAS, the parties have had discussions relating to the funding of certain public improvements as set forth in an annexation agreement between the parties relating to the new high school;

WHEREAS, the parties have reached an accord regarding the issue of funding; NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. The Village will enter into a contract with Freesen, Inc., to construct the signalization at Peachtree and Plummer Boulevard, and the asphalting of Plummer Boulevard, during the calendar year 2001.
- 2. The District will pay the Village the sum of \$58,000 toward the Freesen contract, as follows: one-half on or before June 1, 2001; and the other half upon completion of the construction.
