**AN ORDINANCE APPROVING A CONTRACT
WITH GREG ZAK D/B/A NOISE SOLUTIONS BY GREG ZAK**


*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: That certain Agreement with Greg Zak d/b/a Noise Solutions by
Greg Zak, a copy of which is attached hereto, is hereby approved.

SECTION 2: The Village President is hereby authorized to execute the contract
on behalf of the Village and to designate the contact person as set forth in the contract, and
thereafter, the proper officers and employees of the Village are authorized and directed to
carry out the contract according to its terms.

SECTION 3: This Ordinance is effective immediately.

CONTRACT

This contract is between Greg Zak d/b/a Noise Solutions by Greg Zak, ("Zak") and the Village of Chatham, Illinois, an Illinois municipal corporation ("Client").

A. Client hereby engages Zak as a consultant to perform noise measurement, analysis and testimony as directed from time to time by Client. Client shall designate a contact person to direct the efforts of Zak. Client shall pay Zak the sum of \$1.65 per minute (\$99/hour) for noise measurement and analysis services, plus \$3.30 per minute (\$198.00/hour) for any time spent testifying, whether in a deposition or in a trial. There will be a minimum court show up charge of two hours, or \$396.00.

B. In addition to charges for professional services, Client will also be responsible for necessary and reasonable costs and expenses incurred by Zak on behalf of Client, including travel expenses, which will be charged at \$0.345 per mile.

C. Zak shall submit bills from time to time at the conclusion of a segment of professional services provided. The bills shall be paid in full and within 30 days of the billing date.

D. Initially, Zak shall not incur professional charges (exclusive of expenses) exceeding ~~\$500.00~~ without the verbal or written consent of Client. Should Client give verbal or written authorization for continued professional services, then Zak will continue to perform professional services, and Client will agree to pay for said services.

E. This contract is effective upon its approval by ordinance of Client and its execution by the parties, and shall remain in effect until cancelled by either party. Either party may cancel service at any time upon written notice to the other; however, Zak shall be entitled to full payment for services rendered prior to cancellation

F. Zak shall provide Client with written and verbal reports of all noise related services as agreed.

G. Should a court of law determine any portion of this contract to be invalid, the remainder shall remain in full force and effect.


