ORDINANCE 02 - 02

AN ORDINANCE IN REFERENCE TO VILLAGE EMPLOYMENT

**WHEREAS**, the Accounting Department posted the position of Accounting Technician on the department bulletin board; and

**WHEREAS**, on January 3, 2002 recommendations from the Director of Administration and Utilities, and the Chief Fiscal Officer were presented to the Administration Committee, who is recommending the appointment of Alice O'Keefe as the preferred candidate.

**BE IT ORDAINED**, by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**SECTION 1:** Alice O'Keefe shall be employed as an Accounting Technician on a full time basis to be paid an hourly wage of \$11.901 from the passage and approval of this Ordinance until May 1, 2002; at which time the hourly wage shall be \$12.51; until successful completion of a six month probationary period at which the hourly wage shall be \$12.51. Salary and associated expenses shall be equally distributed from the Electric, General and Water funds.

**SECTION 2:** This Ordinance shall be in full force and effect upon passage and approval.
