ORDINANCE NO. 02-45

AN ORDINANCE RELATING TO STOP SIGNS ON ATCHISON ROAD AND COVERED BRIDGE ROAD

WHEREAS, pursuant to Section 11-304 and other sections of the Illinois Vehicle Code, local authorities are required to place and maintain such trafffic control devices upon highways under their maintenance jurisdiction as are required in their discretion to indicate and carry out the provisions of the Illinois Vehicular Code: and

WHEREAS, pursuant to Section 11-305 and other sections of the Illinois Vehicular Code, the driver of any vehicle shall obey the instructions of any official traffic control device; and

WHERAS, Staff have reviewed the appropriate traffic manuals and are recommending the placement of stop signs on Atchison Road at Covered Bridge Road. Lack of sight distance on the north leg of the intersection brings rise to safety concers.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Chapter 71, Schedule I of the Village Code of Ordinances is amended by the addition of the following:

Street Which Stops Covered Bridge Road

Direction of Travel East and West

Stop at Entrance To Atchison Road

Covered Bridge Road

Atchison Road

North and South

SECTION 2 This ordinance shall take effect upon its passage and approval as provided by law. The Clerk shall forthwith publish this ordinance in pamphlet form and see to its inclusion in the next update of the Village Code of Ordinances.
