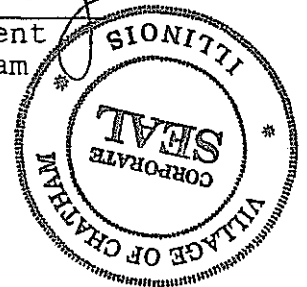
SECTION 1: That the bid from Capitol Waste Systems for \$225.00 per loaded 30 yard container and no charge for loaded Appliance Container.
