## AN ORDINANCE APPROVING AN EQUIPMENT LEASE WITH UNITED COMMUNITY BANK

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: A proposed lease with United Community Bank of Chatham which:

- a. Refinances a lease entered into in June, 2004 for 4 squad cars pursuant to ordinance number 04 31;
  - b. Adds one squad car to the lease, for a total of five;
- c. Is in a total amount not to exceed \$73,500; and has a term of three years at an interest rate of 3.39%, with an option to purchase the squad cars at the conclusion of the lease for nominal consideration, is hereby approved.

SECTION 2: The Village President is hereby authorized to execute the lease agreement, and thereafter, the proper officers and employees of the Village are authorized and directed to carry out the lease according to its terms.

SECTION 3: This Ordinance is effective upon its passage by a 2/3 vote of the corporate authorities, in accordance with Section 11-76-6 of the Illinois Municipal Code.
