AN ORDINANCE ACCEPTING A BID FOR
CONSTRUCTION OF GROUND WORK ON SUBSTATION

WHEREAS; the Village of Chatham sought and obtained bids for the construction of the ground work to prepare for construction of an electric substation in fox Creek Subdivision; and

WHEREAS, the bids dated May 3, 2005 were opened and the lowest responsible bidder was identified; and

WHEREAS, the Public Works Committee met to review said bids and is recommending the lowest bid from Sallenger, Inc. for \$42,112.00.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois as follows:

Section 1: That the bid from Sallenger, Inc. is hereby accepted.

Section 2: That the appropriate officials be and are hereby directed to sign the necessary forms.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


