WHEREAS, the Commission and the Commissioners have periodically informed the Village of the status of those efforts, most recently on May 12, 2005, at a joint meeting of the Public Works Committees of the member villages and the Commission; and,

WHEREAS, the Trustees of the Village attending said meeting have reported to the Village, subsequently confirmed by Resolution 2005-02 of the Commission, that the current available options for the acquisition and operation of a joint waterworks system, or a common source of supply of water, are unacceptable to the member municipalities; and,

WHEREAS, in Resolution 2005-2 of the Commission, the Commission has recommended to the member villages that each member municipality withdraw from participation in the Commission upon the occurrence of certain events, thereby abolishing the Commission and permitting each of the member municipalities to consider and seek alternate solutions for a source of supply of water for their respective communities;

SECTION 2: That the Village hereby elects to revoke its participation in the Chatham-Rochester Water Commission, effective upon the earlier of notification by the Commissioners of the Commission, that all affairs of the Commission have been concluded and that necessary arrangements for the preservation of the Commission's records, resolution of its final obligations and repayment of debt of the Commission by the member municipalities has been concluded or has been provided for, or sixty (60) days following the date of adoption of this Ordinance.

SECTION 3: That the Village Treasurer is hereby authorized, empowered and directed to notify Rochester State Bank and Marine Bank, Springfield, that future statements for the proportionate share of the Commission debt due from the Village should be directed to the Village at Village Hall for payment.

SECTION 4: That the Clerk of the Village is hereby authorized, empowered and directed to transmit a Certified copy of this Ordinance to the Village

President of Rochester and the Chairman of the County Board of Sangamon County.

SECTION 5: That all Ordinances, Resolutions and other enactments of the

Village in conflict herewith are hereby expressly repealed to the extent of said conflict.

Dear Mayor Gray:

I am writing to you at the unanimous direction of the Commissioners of the Chatham-Rochester Water Commission after adoption of Resolution of 2005-2 entitled a "Resolution Informing The Member Municipalities Of The Condition Of The Commission And Making Recommendations In Connection Therewith." This Resolution was unanimously adopted by the Commissioners present at their meeting of Thursday, May 26, 2005.

At the Joint Meeting of the Public Works Committee of Rochester and Chatham, along with the Commission, conducted on May 12, 2005, it became apparent to the Commissioners that no consensus exists on a strategy for the continuation of the Commission's activities or the development and construction of a water production and distribution facility for the benefit of the member municipalities. As a result, at that meeting, the Commissioners agreed to consider a Resolution making recommendations to the member municipalities. A certified copy of that Resolution is enclosed with this letter.

The Resolution contains a recital of the current view of the Commissioners regarding previous directions issued to the Commission by the member municipalities and the current circumstances giving rise to the lack of consensus on future steps to be taken with respect to this Project. As a result, it is the view of the Commissioners that the most appropriate step is the disbandment of the Commission.

Our counsel has informed us that the appropriate manner in which to approach the disbandment is for the member municipalities to withdraw participation from the Commission. Under separate cover, our counsel will communicate with your attorney to prepare and present such an Ordinance for consideration by your Board of Trustees. Assuming that both communities adopt similar, or identical, Ordinances, the Commission will then take the necessary steps to conclude its remaining activities, provide for the payment of its liabilities, and disband at the earliest possible time. Of course, the individual community representatives are available to talk with you regarding this step.
