AN ORDINANCE APPROVING A BID TO PURCHASE A MOWER

WHEREAS, on July 11, 2005 the Village of Chatham sought and obtained bids to purchase a mower for the Public Properties Department; and

WHEREAS, the attached bid was opened and the lowest responsible bidder identified; and

WHEREAS, on July 19, 2005 the Public Works & Utilities Committee met to review the attached bid, being only one bid which met specifications, and is recommending acceptance of the bid from Carver's Westside Power Equipment for the amount of \$7,927.00.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the bid from Carver's Westside Power Equipment for \$7,927.00 is hereby approved.

SECTION 2: This Ordinance is effective upon its passage and approval.

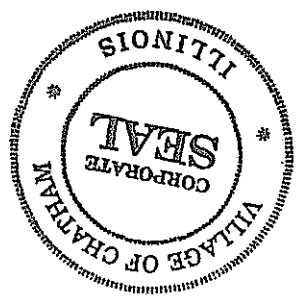

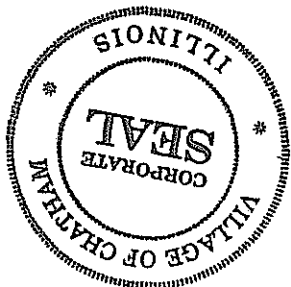
