AN ORDINANCE ACCEPTING A

WHEREAS, on September 2, 2005 at 1:00 p.m. the bids were opened and the lowest responsible bidder identified. The bids have been reviewed and staff is recommending the lowest bid from Lake Area Disposal Service Inc. for \$14,000.00.


