## AN ORDINANCE APPROVING THE FINAL PLAT OF SUBDIVISION OF THE WILLOWS SUBDIVISION PLAT 2

WHEREAS, on 9-8-05, 2005, the Planning Commission of the Village of Chatham reviewed and recommended approval of Plat 2 of the Willows Subdivision.

WHEREAS, proper security for Plat 2 has been tendered by the Developer of the Willows Subdivision.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: The final plat of subdivision of The Willows Subdivision, Plat 2, is hereby approved, conditional upon review of the covenants for the subdivision.

**SECTION 2**: The President is authorized and directed to sign said Plat 2 on behalf of the Village upon certification by the Village Attorney that the covenants comply with the Village Subdivision Ordinance.

SECTION 3: As recommended by the Consulting Engineer for the Village pursuant to Exhibit A hereto, surety in the amount of \$30,000 for construction of the public improvements in the Willows Subdivision, Plat 1 is hereby approved. Letter of Credit No. SLCLSTL01917, issued by U.S. Bank on September 7, 2005 and attached as Exhibit B, is approved as surety therefor.

**SECTION 4**: This Ordinance is effective immediately.
