AN ORDINANCE REZONING CERTAIN PROPERTY AND APPROVING A LOCATION AND SKETCH MAP (Northpointe Subdivision Property)

WHEREAS, the owner and developer of land legally described in a Zoning Plat attached hereto has petitioned that the land be rezoned;

WHEREAS, a location and sketch map has been submitted for such property relating to development of a subdivision therein to be known as Northpointe Subdivision;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The Property legally described on a Zoning Plat attached hereto and prepared by Greene & Bradford, Inc. and dated January 4, 2006, which was

the subject of a Zoning Petition filed on October 31, 2005, is hereby rezoned from its present classification of R-1, as follows:

- 1. Tract 1, consisting of 54.823 acres, is rezoned R-1A.
- 2. Tract 2, consisting of 11.059 acres, is rezoned R-2.
- 3. Tract 3, consisting of 9.237 acres, is rezoned R-3A.

SECTION 2: The location and sketch map for Northpointe Subdivision is approved.

SECTION 3: This Ordinance is effective immediately.
